



AHHS Exam Exemption Guidelines 2022

FALL

Fall semester exam exemptions will allow all students with good behavior, character, and academic performance to exempt **up to 3 semester exams**. Semester exam exemption guidelines will apply to all students who meet the following criteria:

Fall Semester: Students can exempt up to 3 exams with the exception of OnRamps, Dual Credit English 3 & 4 and ALL AP courses.

Unweighted Semester Grade Average
80 or above

Calculation of Grades:

- Grades are calculated in the following manner for the terms of exam exemptions.
Report card for 1st 9 weeks final average (MP1) multiplied by 3.
Second progress report of the 2nd 9 weeks multiplied by 2.
These two totals are added together and divided by 5 to get the average used to determine eligibility.

To qualify for exemptions, a student must not have:

- Academic integrity violations and/or been assigned to DAEP.
- More than 6 absences in ANY class (excused or unexcused), including Non-Credit classes: Personalization, Study Hall, Athletic Aide, Attendance/Principal Aide, Class Aide, Guidance Aide, Library Aide. Students who have make-up hours will not qualify for exam exemptions, and students may not regain eligibility for exam exemptions by completing make-up hours. Tardies do not count towards exam exemptions. ABX does not count against attendance.
- Missed the AHHS Exam Exemption Form deadline: **Wednesday, December 7, 2022 @ 4:00 p.m.**

Please note that semester exam exemptions shall be revoked if a student fails to meet any of the criteria after the exemption form has been turned in and approved by an administrator.

A student who feels that an exemption has been unfairly denied may appeal by completing an Appeal of Denied Exam Exemption form and returning it to the Dean's office within two school days of being notified of the denial. The Dean and/or designee will approve or deny the appeal prior to the start of exams.

AHHS Exam Exemption Guidelines 2023

SPRING (9th- 11th Grades)

Spring semester exam exemptions will allow all 9th- 11th grade students with good behavior, character, and academic performance to exempt **up to 3 semester exams (with no repeats from fall semester)**. Semester exam exemption guidelines will apply to all students who meet the following criteria:

Spring Semester: Students can exempt up to 3 exams (including AP courses) with the exception of OnRamps and Dual Credit English 3.

Unweighted Semester Grade Average
80 or above

Calculation of Grades:

- Grades are calculated in the following manner for the terms of exam exemptions.
Report card for 3rd 9 weeks final average (MP3) multiplied by 3.
Second progress report of the 4th 9 weeks (IPR 5/2/23) multiplied by 2.
These two totals are added together and divided by 5 to get the average used to determine eligibility.

To qualify for exemptions, a student must not have:

- Academic integrity violations and/or been assigned to DAEP.
- More than 6 absences in ANY class, including Non-Credit classes: Personalization, Study Hall, Athletic Aide, Attendance/Principal Aide, Class Aide, Guidance Aide, Library Aide. Students who have make-up hours will not qualify for exam exemptions, and students may not regain eligibility for exam exemptions by completing make-up hours. Tardies do not count towards exam exemptions.
- Missed the AHHS Exam Exemption Form deadline: **Wednesday, May 10, 2022 @ 4:00 p.m.**

Please note that semester exam exemptions shall be revoked if a student fails to meet any of the criteria after the exemption form has been turned in and approved by an administrator.

A student who feels that an exemption has been unfairly denied may appeal by completing an Appeal of Denied Exam Exemption form and returning it to the Dean's office within two school days of being notified of the denial. The Dean and/or designee will approve or deny the appeal prior to the start of exams.

AHHS Exam Exemption Guidelines 2023

SPRING (12th Grade ONLY)

Spring semester exam exemptions will allow all seniors with good behavior, character, and academic performance to exempt **all 7 semester exams**. Semester exam exemption guidelines will apply to all seniors who meet the following criteria:

Spring Semester: Seniors can exempt up to 7 exams with the exception of OnRamps and Dual Credit English 4.

Unweighted Semester Grade Average
80 or above

Calculation of Grades:

- Grades are calculated in the following manner for the terms of exam exemptions.
Report card for 3rd 9 weeks final average (MP3) multiplied by 3.
Second progress report of the 4th 9 weeks (IPR 5/2/23) multiplied by 2.
These two totals are added together and divided by 5 to get the average used to determine eligibility.

To qualify for exemptions, a student must not have:

- Academic integrity violations and/or been assigned to DAEP.
- More than 6 absences in ANY class, including Non-Credit classes: Personalization, Study Hall, Athletic Aide, Attendance/Principal Aide, Class Aide, Guidance Aide, Library Aide. Students who have make-up hours will not qualify for exam exemptions, and students may not regain eligibility for exam exemptions by completing make-up hours. Tardies do not count towards exam exemptions.
- Missed the AHHS Exam Exemption Form deadline: **Wednesday, May 10, 2022 @ 4:00 p.m.**

AHHS Pautas de Exención de Exámenes 2022

Las exenciones de los exámenes del semestre de primavera permitirán que todos los estudiantes de último año con buen comportamiento, carácter y rendimiento académico estén exentos de los 7 exámenes del semestre. Las pautas de exención de exámenes semestrales se aplicarán a todos los estudiantes de último año que cumplan con los siguientes criterios:

Semestre de primavera: los estudiantes de último año pueden ser exentos de hasta 7 exámenes con la excepción de Doble Crédito Inglés 4.

Promedio semestral no ponderado
80 o más

Cálculo de Grados:

- Las calificaciones se calculan de la siguiente manera para los términos de las exenciones de exámenes.
Boleta de calificaciones del tercer promedio final de 9 semanas (MP1) multiplicado por 3.
Segundo informe de progreso de las cuartas 9 semanas multiplicado por 2.
Estos dos totales se suman y se dividen entre 5 para obtener el promedio utilizado para determinar la elegibilidad.

Para calificar para las exenciones, un estudiante no debe tener:

- Más de 4 ausencias injustificadas en las siguientes clases sin crédito: Personalización, Sala de estudio, ASC, Ayudante atlético, Ayudante de asistencia/director, Ayudante de clase, Ayudante de orientación, Ayudante de biblioteca empezando el **14 de Febrero de 2022**.
- No haber cumplido con la fecha límite del AHHS Formulario de Exención del Examen: **miércoles, 4 de mayo de 2022 a las 4:00 p. m.**

Tenga en cuenta que las exenciones de exámenes semestrales se revocarán si un estudiante no cumple con alguno de los criterios después de que haya entregado el formulario de exención y haya sido aprobado por el administrador.

Un estudiante que sienta que una exención ha sido denegada injustamente puede apelar completando un formulario de Apelación de Exención de Examen Denegado y devolverlo a la oficina del Decano dentro de dos días escolares posteriores a la notificación de la denegación. El Decano y/o su designado aprobarán o negarán la apelación antes del comienzo de los exámenes.
